Acorn Capital - Investment Update


"The S&P/ASX Small Ordinaries Accumulation Index declined by 2.8% over the month, slightly outperforming the large-cap ASX100 index which fell by 3.9%. The most significant sector declines were observed in Energy (-13.4%), Health Care (-6.9%), and Information Technology (-5.5%). Communication services emerged as the sole sector to deliver a gain for the month.

Noteworthy contributors to the portfolio included MA Financial (+25.8%), driven by a FY24 result that met consensus, showcasing improved performance across various areas. Positive management outlook and reduced future investment requirements further buoyed investor sentiment. Predictive Discovery also made substantial gains of 32.6%, on M&A potential after two large mining companies made a placement at a premium to the recent trading price.

Conversely, notable detractors included Petratherm (-30.4%) after a robust three-month upswing, potentially exacerbated by market anticipation of an upcoming capital raise. Opthea saw a decrease of 14.7% following a solid but not spectacular quarterly update and the announcement of a USD15m venture debt package aimed at supporting growth initiatives. On the positive side the funding removes an overhang but on the negative side we are cautious on cash burning companies utilising debt to fund their growth. We will be watching very closely for evidence of an acceleration in sales to mitigate the increased financial risk."



ACQ Objective

The Objective is to create a diversified portfolio of listed microcap companies and then to invest opportunistically in unlisted entities that offer better relative value. The performance objective for ACQ is to outperform the S&P/ASX Small Ordinaries Accumulation Index over the medium to long term.

Dividend Intention

Acorn Capital Investment Fund Limited intends to pay annual dividends targeting at least 5% of closing post-tax NTA for each financial year, franked to the highest extent possible and without the Company incurring a liability.

Where the Company accumulates franking credits that the Board determines are in excess to its requirements it is the intent to distribute those excess credits by way of special dividends. This is subject to the Company having sufficient profit and cash flow to make such payments.

Investment Philosophy

The investment philosophy is based on a belief that there are pricing inefficiencies amongst emerging or microcap companies due to a lack of readily available external research conducted on such entities.

Acorn Capital believes that through a research driven investment process the pricing inefficiencies that exist in both listed microcaps and unlisted microcaps can be exploited to earn returns superior to those available in the broader market.

Unlisted microcap opportunities must be of better relative value on a risk-adjusted basis to displace existing listed portfolio investments in the corresponding sector.
